

**REQUEST FOR PROPOSALS
FOR PROFESSIONAL SERVICES OF A PLANNING BOARD ENGINEER**

The Township of Alloway ("Township") is requesting Proposals from firms licensed in the State of New Jersey to serve as Planning Board Engineer from January 1, 2025 to December 31, 2025. Requests for Proposals are being solicited through a fair and open process in accordance with N.J.S.A. 19:44A-20.5.

Submissions will be evaluated by the Planning Board of the Township of Alloway on the basis of the most advantageous, price and other factors considered. The evaluation will consider:

- a. Experience and reputation in the field;
- b. Knowledge of the Township of Alloway and the subject matter to be addressed under the contract;
- c. Availability to accommodate any required meetings of the Planning Board;
- d. Compensation proposal;
- e. Knowledge and experience in MLUL, COAH, the RSIS and the Master Plan;
- f. Other factors if demonstrated to be in the best interest of the Township of Alloway.

Requests for Proposals are to be submitted no later than Wednesday, December 11, 2024 at 11:00 a.m. prevailing time in the Alloway Township Municipal Building, 49 South Greenwich Street, Alloway, NJ 08001.

Box 425, Alloway, NJ 08001 and may be received through the mail or presented in person.

Requests for Proposals may be received before the hour designated in this notice if they are mailed or hand delivered in person to the Municipal Clerk's Office, Township of Alloway, 49 South Greenwich Street, Alloway, NJ 08001.

Responders are required to comply with the requirements of P.L. 1975, c. 127 (Affirmative Action) and P.L. 2004, c.57 (Business Registration). Responders are also required to submit a statement of ownership with their proposal as required by P. L. 1977, c. 33 (Disclosure of Ownership).

The Planning Board of the Township of Alloway reserves the right to reject any and all Requests for Proposals, and further reserves the right to waive minor irregularities and immaterial variances or formalities in the proposals received and to accept any proposal which is deemed most favorable to the Township of Alloway, County of Salem, New Jersey at the time and under the conditions stipulated.
