- 2. New Rock Salt Vendor information was reviewed by Committee

Old Business/Updates:

- 1. Tax Collector Ordinance was reviewed Committee.
- 2. PW Salary Ordinance was reviewed by Committee, discussion ensued regarding part time laborers being included in this ordinance. Lois, Treasurer, stated that part time titles will need to be listed in the prospective employee's resolution.
- 3. DEP Floodplain Ordinance Committee is still reviewing it. No further updates.
- 4. Stormwater Tier A Adjudicatory Hearing The Committee is not requesting a hearing; Clerk Vanaman was instructed to have Linwood respond on behalf of the Township.

- 1. Email from Salem County Economic Development Director, Sean Sepsey, was discussed. The Committee would like more information from him regarding other towns that are currently collecting the Short-Term Rental Tax.
- 2. Request from Mayor of Montvale regarding Affordable Housing Litigation was discussed. The Committee agreed they are not interested.
- 3. Regarding the American Flags on the electric poles in town, the Committee agreed that the initiative was taken by a resident without approval, therefore the flags were not the responsibility of the Township.
- 4. Raingarden Agreement ends in October, the Committee agreed that Public Works will maintain it after the agreement expires.
- 5. Halloween Parade Vendors discussion ensued. Deputy Mayor Leady agreed that the Fire house Parking area can be utilized for food vendors if needed.
- 6. Extension of premises application received from Dirty Jersey Tavern, LLC and reviewed by the Committee. Clerk Vanaman was instructed to approve it pending the corrected area to be submitted by the applicant.
